6- and 20-YEAR LIMITED WARRANTY FOR 724-SERIES SHARKSKIN STAIN

Cloverdale Paint Inc. ("Cloverdale") warrants its 724-series SharkSkin solid hide Deck& Siding stain, subject to the conditions contained in this limited warranty for six (6) years on deck surfaces and for twenty (20) years on siding surfaces from the date of purchase. When applied following full label and technical data sheet instructions, this product will:

- NOT chalk to discolour the surrounding surfaces.
- NOT erode to expose the substrate.
- NOT peel or blister from properly prepared surfaces.
- NOT become damaged by normal maintenance and cleansing of dirt.

Conditions:

- This warranty applies where two (2) full coats* of 724-series SharkSkin solid hide stain are applied on properly prepared exterior home cladding consisting of: wood siding, cedar shakes or shingles, composite wood siding or fibre cement board.**
- This warranty applies for six (6) years where two full coats of 724-Series SharkSkin solid hide stain are applied on properly prepared dimensional lumber wood decks consisting of cedar or fir deck grade lumber***, pressure treated lumber or plywood or exterior grade plywoods.

** Full coats are defined as the specified spread rate per application and dry times observed between applications as per label instructions.*

*** Fibre cement siding must be primed with a factory primer or Cloverdale 05133 Alkali Resistant Primer*

**** Badly weathered or oxidized wood will require a prime coat of 15130 Alkyd Stain Blocking Primer*

Limitations:

- Cloverdale and its affiliates shall not be responsible for any failure relating to improper care or application, excessive moisture content of the substrate, unsuitable or improperly prepared surfaces, or less than the recommended amount of product applied as per label instructions.
- This warranty does not apply if failure is caused by delamination of the previous underlying coating system.
- This limited warranty does not apply to problems caused by alteration of this product, misuse, improper storage, abuse or neglect.
- This warranty does not apply where cause of failure is a result of moisture absorption into the underside of the deck. Cloverdale recommends for close to grade level decking, the underside of the deck boards be sealed or a moisture-impermeable membrane be installed below the deck.
- This warranty is not applicable where damage to the coating is caused by power washing.
- This warranty does not apply to other applications of this product on surfaces or materials not listed above. This would include, but not limited to: wood fences, shake or shingle roofs, vinyl clad decks or vinyl siding, aluminum siding, concrete, cement block or other masonry substrates, plastic or composite plastic decking material.
- Mildew, algae and colour permanence are beyond the control of Cloverdale and are explicitly not covered by this Warranty. Depending on colour, additional coat(s) may be required to provide aesthetically desirable results.
- This limited warranty does not include any labour or cost for the application of any stain, and in all cases, the maximum liability of Cloverdale, if any, shall be limited to direct damages only in an amount not to exceed the original purchase price of the product. To the maximum extent permitted by applicable law, Cloverdale expressly disclaims and in no event shall be responsible for any liability for any incidental, special, indirect or consequential damages resulting from any reason whatsoever.
- The limited warranty will only apply if Cloverdale is notified of such failure in writing within thirty (30) days of such failure occurring and Cloverdale is afforded an opportunity to inspect and conduct tests of such areas as deemed expedient and necessary at such time or times as reasonably requested to determine that the cause of such problems arise from a manufacturing defect and is not as a result of improper application thereof.

If this product fails to perform as described, Cloverdale shall provide at its own expense, sufficient replacement product(s) to repaint the affected area or refund the purchase price equivalent to product used on the affected area.

Except for the limited warranty expressly provided above, to the maximum extent permitted by applicable law, Cloverdale disclaims all other warranties.

All claims must be submitted in writing and accompanied by proof of purchase. Claims may be made at the Cloverdale Paint location where the product was purchased or mailed to the address below.
